

LIABILITY WAIVER**COMMITMENT TO PARTICIPATION IN CHICAGO SPRING HALF MARATHON + 10K**

I, the undersigned participant, understand that any and all participation in the Team AHC charity run is completely voluntary, and not contingent upon any relation or affiliation to Association House of Chicago. I agree to indemnify and hold harmless Association House of Chicago (henceforth abbreviated as “AHC”, or referenced as “we”, “us” or “our”), its directors, officials, and other participants, sponsoring agencies, sponsors, advertisers, and owners and lessors of premises used to conduct the event from all liability, claims or demands arising from any injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the releasees or otherwise, due to my voluntary participation in the Team AHC charity run for the 2023 Chicago Spring Half Marathon and any and all activities therein, to the fullest extent permitted by law. This waiver should be binding on heirs, executors, administrators, assigns, agents, attorneys and representatives.

I further understand that running a race is a potentially hazardous activity, which could cause injury or death. I will not enter and participate unless I am medically able and properly trained, and, by my signature, do so certify that I am medically able to perform this event, am in good health, and that I am properly trained. I do hereby waive all claims for damage or loss to my person or property which may be caused by any act or failure to act, by Association House of Chicago, its officers, agents, or employees arising directly or indirectly from my participation in this event. I hereby assume all liability for any loss, damage, or other liability from such participation.

PRIVACY AND PUBLICITY

I understand that my name, photograph, voice or likeness may be used by Association House of Chicago, its team, agents and others working for it or on its behalf. I assign onto Association House of Chicago the unlimited right and permission to use, distribute, publish, exhibit, digitize, broadcast, display, reproduce, and otherwise leverage my name, (or if AHC so chooses, any fictional name identifying me), picture, voice, likeness or biographical information and any material based thereon or derived therefrom, for the purposes of advertising, promoting and/or publicizing AHC, our team, or our products and services.

I shall have no right of approval, no claim to additional compensation, and no claim arising out of any use, alteration, fictionalization, blurring, distortion, faulty reproduction, illusionary effect, or use in any composite form of my name, picture, voice or likeness or biographical information. I consent to and authorize, in advance, such use and waive any rights of privacy and/or publicity I may have in connection therewith.

COMMITMENT TO THE FUNDRAISING MINIMUM

I understand that by participating in the Team AHC charity run for the 2023 Chicago Spring Half Marathon I am responsible for meeting my designated fundraising minimum of \$500 no less than one week after the event - by

Sunday, May 21, 2023. Regardless of my participation in the race or any other circumstances, I agree to submit payment to Association House of Chicago for the remaining difference (the fundraising minimum minus all donations accrued by May 21, 2023) and make my own donation to reach this minimum goal. If I am, for any reason, unable to participate in the 2023 Chicago Spring Half Marathon, all money raised will remain with Association House of Chicago and cannot be counted toward any future race activity. I commit to responding to communication from Association House of Chicago regarding my fundraising commitment and will provide updated and accurate payment information so that the difference may be covered (only if necessary). I will therefore permit Association House of Chicago to invoice me on Tuesday, May 23, 2023 for the remaining difference between my fundraising total and \$500, only if my fundraising total is less than \$500.

I have read the Commitment to the Fundraising Minimum carefully and understand my commitment to raise at least \$500 by May 21, 2023.

MARATHON RULES

I agree to abide by all the event rules established by the 2023 Chicago Spring Half Marathon.

OTHER ACKNOWLEDGMENTS

I understand that registering for the 2023 Byline Chicago Spring Half Marathon & 10K is separate from any Association House of Chicago paperwork. I further understand that by pledging with AHC and by filling out its paperwork, I have not yet officially registered for the Chicago Spring Half Marathon.
